



**RELEASE FROM LIABILITY, ASSUMPTION OF RISK,
COVENANT NOT TO SUE, AND INDEMNITY AGREEMENT**

In exchange for Jones Lang LaSalle Americas, Inc. (“JLL”) allowing you to observe and/or participate in the **Supply Chain & Logistics Solutions Conference – April 28-30, 2025** (“Event”) or being permitted to enter for any purpose the “Designated Area” (defined as the entire premises supporting the Event), and for other good and valuable consideration, the receipt of which is hereby acknowledged, you, for yourself and your personal representatives, heirs, and next of kin, do hereby, to the fullest extent permitted by applicable law:

1. Acknowledge, agree, and represent that you have or will immediately upon entering the Designated Area, and will continuously thereafter, inspect the Designated Area, and you further agree and warrant that, if, at any time, you are in or near the Designated Area and you feel unwell or unsafe, you will immediately advise the JLL officials orchestrating the Event of such feeling, and if necessary will leave the Designated Area or refuse to participate further in the Event or to observe it within the Designated Area.
2. Release, waive, and forever discharge JLL, its parent, subsidiaries, and affiliate companies, their respective officers, directors, members, shareholders, employees, representatives, agents, successors, or assigns (individually a “Releasee”, collectively the “Releasees”), from any and all direct or third party liability to you, your personal representatives, assigns, heirs, and next of kin for all losses or damages and all related claims, on account of injury to you (including death) or your property, arising from or relating to your participation in the Event.
3. Covenant and agree not to commence or maintain suit against any one or more of the Releasees for injuries sustained (including death) or damages incurred and agree to indemnify, save, and hold harmless Releasees from and against any and all direct or third party loss, liability, injuries sustained (including death), damage, or cost incurred which may arise or relate in any way to presence or participation in the Event, whether caused by any act or omission of any Releasee or otherwise.
4. Assume full responsibility for any risk of bodily injury (including death) or property damage arising out of or related in any way to your custody or presence or participation in the Event, whether caused by any act or omission of any Releasee or otherwise.
5. Acknowledge that the activities included in the Event are dangerous and involve the risk of serious injury, death, and property damage, and that any injury sustained may be compounded or increased by negligent acts or omissions of the Releasees.
6. Acknowledge that JLL has taken all actions reasonably necessary to maintain the premises and operate the Event in a safe and orderly manner.
7. Acknowledge and agree that JLL makes no representation or warranty that the Event will be error-free or without fault, and that any and all participation in the Event, which shall include any and all latent defects in the Designated Area, shall be at your sole and exclusive risk.

This RELEASE FROM LIABILITY, ASSUMPTION OF RISK, COVENANT NOT TO SUE, AND INDEMNITY AGREEMENT shall be governed by and construed in accordance with the applicable substantive laws of the State of Illinois, without giving effect to its conflicts of laws rules. BOTH YOU AND JLL EXPRESSLY ACKNOWLEDGE AND AGREE THAT THEY HEREBY WAIVE AND RELINQUISH THEIR (AND THEIR AFFILIATES’) RESPECTIVE RIGHT(S) TO A TRIAL BY JURY ON ANY AND ALL ISSUES.

You acknowledge and agree that you have read this RELEASE FROM LIABILITY, ASSUMPTION OF RISK, COVENANT NOT TO SUE, AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO YOU.
